**ORDINANCE NO. 94-12**

**AN ORDINANCE ESTABLISHING THE BENGUET PUBLIC HIGH SCHOOLS STUDENTS' INCENTIVE ALLOWANCE FUND**

**NOW THEREFORE,** on motion of Hon. James M. Malaya and unanimously seconded,

**BE IT ORDAINED BY THE SANGGUNIANG PANLALAWIGAN IN SESSION ASSEMBLED, THAT:**

- Section 1.** This Ordinance shall be known as the Benguet Public High School Student's Allowance Fund.
- Section 2.** Benguet Public High Schools refer to all existing high schools in the Province of Benguet and public high schools that may be created thereafter.
- Section 3.** The following students enrolled in the public high schools defined in Section 2 hereof are hereby granted an incentive allowance of ONE HUNDRED (P100.00) PESOS a month each for a period of ten (10) months for each school term to any qualified student-awardee, who:
  - a. Completed elementary education as first honors until he/she finished his/her secondary education;



- b. obtained/got first honors in the first, second and third year classes upon enrollment in the school term and thereafter if he/she maintains the same;
- c. Is certified to by either the schools superintendent, school administrator, principal, or head teacher as an awardee of a Gold medal in the case of any individual sport, or a team member of any team sports awarded the gold medal in the regional/national athletic meet and thereafter if he/she maintains the same; Provided, However, that no athlete-awardee shall be a recipient of more than one incentive allowance;
- d. is an Editor-in-Chief of the school's publication; CAT Corps commander; and President of the centralized student government; Provided, However, that no student-awardee shall be entitled to more than one incentive allowance;
- e. is a member of the school band duly certified to by the school head; Provided, However that the members of the school band shall not exceed thirty (30). In case it exceeded thirty (30), the members shall divide among themselves equally the amount due them;

**Section 4.** The sum of SIX HUNDRED SEVENTY THOUSAND PESOS (P870,000.00) is hereby appropriated from any savings/ or surplus not otherwise appropriated and/or from the 20% Provincial Development Fund for 1995, under the category of youth development, whichever is deemed proper and appropriate; and thereafter to be included in the annual performance budget which may be increased in accordance with the number of student-awardees.


**Section 5.** It shall be ministerial on the part of the Provincial Treasurer to pay the amount due the student-awardee either directly or thru the school head upon submission of duly certified documents or supporting papers.


**Section 6.** This Ordinance shall take effect during the school year 1995-1996.
