PROVINCIAL ORDINANCE 95-14

AN ORDINANCE CREATING THE POSITIONS OF LEGISLATIVE RESEARCHERS-LEGISLATIVE STAFF ASSISTANT III, 6-10 TO SERVE UNDER THE OFFICE OF THE SANGGUNIANG PANLALAWIGAN AND BOARD MEMBERS TO BE TAPPED FROM REALIGNMENT OR CONVERSION OF AVAILABLE VACANT POSITIONS FROM SELECTED DEPARTMENTS

EXPLANATORY NOTE

There is urgent need to employ legislative researchers under the Office of the Sangguniang Panlalawigan, Province of Benguet the purpose of which is to provide legislative research and administrative service assistance for the members of the Provincial Board;

The Sangguniang Panlalawigan Office lacks these needed personnel;

Recruiting additional personnel for the Province of Benguet is prohibited considering the ceiling requirement on personnel employment;

The remedial measure is to either adopt personnel position realignment or by conversion from available vacant positions from departments with overstaffed plantilla;

The Office of the Provincial Governor is presently conducting an evaluation of various offices to determine those with overstaffed and also those with understaffed personnel;

NOW THEREFORE, be it enacted by the Sangguniang Panlalawigan

Section 1. There is hereby established in the Sangguniang Panlalawigan legislative researchers-Legislative Staff Assistant III, G-10 positions emanating from existing vacant positions through the process of conversion or realignment or transfer;

Section 2. The Provincial Governor or his duly authorized representative shall undertake the study, review and recommendation of the existing vacant positions for appropriate action;

Section 3. The civil service rules and regulations shall be strictly complied with, with the assistance from the personnel of the Province;

Section 4. The Legislative Researchers-Legislative Assistant III, G-10 as soon as qualified and appointed shall be assigned to the Offices of the Members of the Sangguniang Panlalawigan. Qualification Standards for aforesaid position are as follows:

- a) Education Requirements - Completion of Two Years Studies in college;
- b) Experience Requirements - 2 years relevant experience;
- c) Training Requirements - 8 hours of relevant training;
- d) Eligibility Requirements - Career Service (Subprofessional); Appropriate Eligibility for First Level Position.

Section 5. This ordinance shall be effective 15 days after approval.
