**PROVINCIAL ORDINANCE NO. 96 - 21**

**AN ORDINANCE REQUIRING ALL PROVINCIAL VEHICLES AND EQUIPMENTS, WHETHER THE SAME WAS DONATED OR ISSUED THROUGH MEMORANDUM RECEIPT TO THE PROVINCE OR ARE BOUGHT SOLELY OR PARTIALLY FROM PROVINCIAL FUNDS, TO BE MARKED OR PRINTED IN BOLD LETTERS AND FIGURES ON BOTH SIDES OF THE VEHICLES OR EQUIPMENTS WITH THE OFFICIAL SEAL OF THE PROVINCE AND BELOW IT THE WORDS "FOR OFFICIAL USE ONLY" AND PROVIDING PENALTIES FOR VIOLATION THEREOF.**

As proposed by Hon. Samson. C. Paran and on motion duly seconded, be it

**ORDAINED** by the Sangguniang Panlalawigan of Benguet in session assembled, the following :

**SECTION 1.** All provincial government vehicles and equipments, whether the same is donated or issued through memorandum receipt to the province or to any of its official or employee of the province or whether bought partially or wholly by provincial funds, shall be marked or printed legibly in bold letters on the left and right sides of the vehicle or equipment with the official seal of the Province and below it the words "**FOR OFFICIAL USE ONLY**", as follows :

( Official Seal )  
**FOR OFFICIAL USE ONLY**

Provincial vehicles and equipments shall mean to include vehicles and equipments under the administrative supervision of any office, official or employee of the province whether issued for special projects or other purposes; vehicles bought partially or wholly from special funds like the **Special Education Fund** of the province; vehicles being utilized by various health and hospital facilities of the province like hospital ambulances and services; and all other vehicles and equipments administered by the province and its various offices;

**SECTION 2.** The markings as required herein shall always be maintained or reprinted to be legibly and easily discernible at a distance. A uniform bright color shall be utilized for the purpose to all provincial vehicles and equipment;

**SECTION 3.** All provincial vehicles shall be marked in accordance with this ordinance and its implementing rules within **SIXTY (60) DAYS** from approval of the ordinance;

**SECTION 4.** Any person who drives or operates a provincial vehicle or equipment which does not bear the necessary markings as provided herein shall be penalized as follows :

**First Offense** - Suspension from one (1) month for officials and employees, and penalty of P1,000.00 for other persons;

**Second Offense** - Suspension of six (6) months for officials and employees, and penalty of P2,500.00 for other persons;

**Third Offense** - Dismissal from service for officials and employees, and imprisonment of six (6) months plus a fine of P5,000.00 or both at the discretion of the court, for other persons;

**SECTION 5.** The amount of **TWENTY FIVE THOUSAND PESOS (P25,000.00)** is hereby appropriated from the Unappropriated Surplus of the shares from the National Wealth to be utilized for the implementation of this ordinance; This amount shall be coursed through the Provincial General Services Office for implementation of the same;

**SECTION 6.** The Provincial Governor is hereby authorized to issue the necessary implementing rules and regulations in accordance with the provisions of this ordinance and for its immediate implementation;



**SECTION 7.** This Ordinance shall take effect in accordance with the provisions of the Local Government Code of 1991.






