PROVINCIAL ORDINANCE NO. 96 - 22

PROVIDING FOR HIRING OF A CASUAL DRIVER FOR THE OFFICE OF THE SANGGUNIANG PANLALAWIGAN AND AUTHORIZING THE PROVINCIAL VICE GOVERNOR TO HIRE AND APPOINT THE CASUAL DRIVER AND APPROPRIATING FUNDS THEREOF.

EXPLANATORY NOTE

The Sangguniang Panlalawigan recently acquired a new Mitsubishi L-300 Van for the use of SP Members and staff. This is in addition to the two old vehicles acquired many years ago.

There are, however, only two (2) drivers assigned to the SPO as mandated under its staffing pattern. The 2 drivers are each assigned the two old vehicles without anyone assigned to the new vehicle. Furthermore, a new position of driver cannot be created under the SPO without violating the 55% limitation under the Local Government Code of 1991 on the creation of additional positions in the province.

Hence this measure.

NOW THEREFORE, as sponsored by Hon. Samson. C. Paran and on motion duly seconded, be it

ORDAINED by the Sangguniang Panlalawigan of Benguet in session assembled, the following :

SECTION 1. The Provincial Vice Governor is hereby authorized to hire and appoint one (1) casual driver for the Office of the Sangguniang Panlalawigan to drive or operate the newly acquired Mitsubishi L-300 Van and to be paid on a daily basis in accordance with existing rules and regulations, laws or ordinances;

SECTION 2. The casual driver, as herein provided, shall report directly to the Provincial Vice Governor who shall issue the necessary trip tickets or travel orders on all trips he shall undergo or travel inside or outside the province. He shall not operate or drive any other vehicle unless authorized in writing by the Vice governor;

SECTION 3. The amount of **THIRTY THOUSAND PESOS (P30,000.00)** is hereby appropriated from the Unappropriated Surplus of the General Fund for the salaries and other benefits of the casual driver from September 1, 1996 to December 31, 1996. Any amount necessary for his succeeding salaries and benefits shall be included in the 1997 appropriations of the SPO;

SECTION 4. This Ordinance shall take effect immediately upon its approval.
