PROVINCIAL ORDINANCE NO. 96 - 24

AN ORDINANCE GRANTING AN INCENTIVE IN THE FORM OF DEVELOPMENT PROJECTS TO BARANGAYS AND MUNICIPALITIES WITH TOP RATINGS IN THE EFFICIENT AND PROMPT REAL PROPERTY TAXES COLLECTIONS.



EXPLANATORY NOTE

The main purpose of the proposed measure is to effect increase of income for the government units and promote efficient collections and prompt payments of real property taxes in the province;

It is observed that peoples' awareness of their responsibility in the prompt payment of their taxes is being neglected while there is strong clamor for government assistance in terms of development projects. They should from time to time be reminded of their responsibilities as citizens while those who are dedicated in responding to the government's policies and programs should be given incentives.

As proposed by Hon. Bial A. Palaez and on motion duly seconded, be it

ORDAINED by the Sangguniang Panlalawigan of Benguet in session-assembled, the following :




- SECTION 1.** Barangays and Municipalities with efficient and prompt real property tax collection shall be given incentive in terms of development projects over and above their normal allocations;
- SECTION 2.** Categories of incentives shall be first, second and third among municipalities and first and second among barangays in each of the 13 municipalities in the province;
- SECTION 3.** Screening of the entries shall be the responsibility of a screening committee composed of the Provincial Assessor, Provincial Treasurer and the Provincial Administrator as Chairman who shall submit their findings within the first quarter of every year to the provincial governor for appropriate action.
- SECTION 4.** Development projects to be given as incentives to the accredited winners shall be finalized by the Provincial Development Council with the Provincial Governor as Chairman subject to Sangguniang Panlalawigan approval;
- SECTION 5.** This ordinance shall be effective upon approval of the Sangguniang Panlalawigan and in accordance with the Local Government Code of 1991 otherwise known as RA 7160.




