GRANTING BURIAL ASSISTANCE IN THE AMOUNT OF P10,000.00 TO THE FAMILY OF THE DECEASED PROVINCIAL OFFICIALS AND EMPLOYEES OF THE BENGUET PROVINCIAL CAPITOL

EXPLANATORY NOTE

"WHEREAS, Every time an employee dies, a solicitation paper is being passed around from one department to another seeking for voluntary contributions from both the officials and employees;

The Province would provide burial assistance in the amount of P10,000.00 from any unappropriated funds to help the bereaved family at this time that the cost of commodities is very high, specially the cost of burial among the natives. This would be an additional benefit above all others already provided by law;

NOW THEREFORE, as proposed by Hon. Agosto P. Santos and Hon. Samson C. Paran and on motion duly seconded, be it

ORDAINED, by the Sangguniang Panlalawigan of Benguet, in session assembled, the following;

SECTION 1. The Provincial Government of Benguet shall grant burial assistance in the amount of P10,000.00 from any unappropriated funds to the family of the deceased provincial official or employee of the Benguet Provincial Government;


SECTION 2. The Provincial Government of Benguet shall grant only the burial assistance to permanent employees and officials, provided that for elected officials, it shall be granted only during their tenure of office;


SECTION 3. This ordinance shall take effect immediately upon its approval;
