PROVINCIAL ORDINANCE NO. 97-32

AMENDING SECTION 2 OF PROVINCIAL ORDINANCE NO. 96-26 MANDATING THAT PUBLIC BUILDINGS, ROADS, OR OTHER GOVERNMENT INFRASTRUCTURES OF THE PROVINCE, ERECTED, CONSTRUCTED, OR BUILT ON A LOT DONATED BY A PRIVATE INDIVIDUAL, CLAN, FAMILY, HEIR, ORGANIZATION OR ASSOCIATION, OR ANY PRIVATE ENTITY, SHALL BE NAMED IN FAVOR OF THE DONOR.

"WHEREAS, in 4th Indorsement dated Dec. 19, 1996, Hon. Samson Paran returns 3rd Indorsement dated Dec. 3, 1996 of the Provincial Governor relative to SP Ordinance No. 96-26 mandating that public buildings, roads or a lot donated by a private individual, clan, family, heir, organization, or any private entity shall be named infavor of the donor with the proposal that the observations/objections to Sectio 2 thereof be given due course hence, deleting TWO (2) Sentences of the section which should NOW read as follows:

"SECTION 2. The donation of the land shall be covered by a deed of donation or any other legal document in favor of the province. The deed shall be duly registered with the proper authorities."

Section 1: - Section 2 of Provincial Ordinance No. 96-26 be amended and should read thus:

"Section 2 - The donation of the land shall be covered by a deed of donation or any other legal documents in favor of the province. The deed shall be duly registered with the proper authorities."

Section 2: This Ordinance shall take effect immediately upon its approval.


