**MANDATING THE POSTING OF KILOMETER POSTS IN ALL
PROVINCIAL ROADS IN THE PROVINCE OF BENGUET**

EXPLANATORY NOTE

The absence of a point to determine the kilometrage of provincial roads in the province is the basis of this measure.

It has always been the problem to pinpoint a reference on the road during calamities, accidents, implementation of projects, boundary determination or territorial jurisdiction, determination of tourist spots, and all others which necessitates distance or point determination on the road. During calamities and accidents determination of distance has always been a problem in making reports. In the implementation of projects, the stationing of project sites poses problems and the monitoring the same has always been a puzzle to most members of the monitoring groups. Territorial boundaries between towns and barangays where a road is the determining point is also one consideration. Most tourists also ask the kilometrage of roads when asking for directions and points of reference on the road. Even in ordinary situations when one

wishes to determine the distance he traveled, the absence of a kilometer post would make one wonder on his actual location or his distance from place to place in the province.

As proposed by HON. SAMSON C. PARAN with Hon. Fernando M. Aritao and Hon. Redentor P. Edoc as co-proponent and on motion duly seconded, be it

ORDAINED BY THE SANGGUNIANG PANLALAWIGAN IN SESSION ASSEMBLED, THAT:

SECTION 1. It is hereby mandated to set up kilometer posts in all its provincial roads within a period of THREE (3) YEARS beginning the year 1998. After setting up the kilometer posts, the same shall be maintained by the Provincial Engineering Office and destroyed or lost kilometer posts shall be replaced within a reasonable period of time;

SECTION 2. The provincial engineer shall determine the appropriation of the project within a year as to the number of kilometer posts to be posted and recommend the same to the budget office for funding and inclusion in the annual performance budget. The total number of kilometer posts of all provincial roads shall be divided equally within the three-year period to be funded in the succeeding annual budgets;

SECTION 3. This ordinance shall take effect in accordance with the provisions of the Local Government Code of 1991.


