**ORDINANCE INSTITUTIONALIZING THE PROVINCIAL
DEVELOPMENT INVESTMENT PLAN (PDIP) AS TOOL IN
PROJECT PRIORITIZATION AND BUDGET ALLOCATION**

EXPLANATORY NOTE

"WHEREAS, while the Provincial Development Investment Plan (PDIP) is recognized and utilized as a management tool in the task of project listing, prioritization, and budgetary requirements, its appropriate use is not being strictly applied due to the absence of an approved ordinance as basis for its strict implementation. As actually observed and demonstrated, some priority projects which have been already incorporated in the PDIP are not considered for funding while some priority projects which were not included in the PDIP are in the list of funded projects;

WHEREAS, such practices, with this ordinance when approved, can be avoided for the good of public services in terms of proper project prioritization, proper budget allocation and effective project programming and implementation.

NOW THEREFORE as proposed by Hon. Bial A. Palaez and on motion duly seconded,

BE IT ORDAINED BY THE SANGGUNIANG PANLALAWIGAN IN SESSION ASSEMBLED, THAT:

Section 1. The Provincial Development Investment Plan (PDIP) shall be institutionalized as the basis for project prioritization and budgetary allocation;

Section 2. All official and employees in the Province are tasked to comply, observe and implement this ordinance;

Section 3. For effective implementation of this ordinance, the Provincial Governor is hereby authorized to issue the necessary implementing memorandum;

Section 4. This Ordinance shall take effect upon its approval.


