PROVINCIAL ORDINANCE NO. 99 - 50

AN ORDINANCE AMENDING LETTERS "A" AND "B", SECTION 5 OF PROVINCIAL TAX ORDINANCE NO. 97-41 DATED OCTOBER 13, 1997, COVERING RENTAL FEE FOR THE USE OF MUSEUM ARTIFACTS OWNED BY THE BENGUET CAPITOL MUSEUM THEREBY AMENDING FURTHER PROVINCIAL TAX ORDINANCE NO. 01, S. 1993

EXPLANATORY NOTE

As stated in Provincial Tax Ordinance No. 97-41, one set of musical instrument at the Benguet Capitol Museum is rented for only P50.00 for 24 hours or a fraction thereof and an additional P5.00 for every hour thereafter. The same policy is imposed on the rent of one set native blankets. Based on these conditions, it is evident that the rental fee being imposed on these artifacts can not compensate its depreciation cost. It can not be denied further that the cost for the purchase of native instruments incredibly increased.

BE IT ORDAINED BY THE SANGGUNIANG PANLALAWIGAN, IN SESSION:

SECTION 1. Letters "a" and "b", Section 5 of Provincial Tax Ordinance No. 97-41 is amended to read as follows thereby amending further Provincial Tax Ordinance No. 01, s. 1993:

"a. One (1) set (6 pcs.) Musical Instruments consisting of one (1) Solibao; one (1) Kimbal; one (1) Kalsa; one (1) Pinsac; and one (1) pair palas for 24 hours or fraction thereof - **P250.00** and an additional **Twenty (20) pesos** for every hour thereafter.












b. One (1) set (3) pair Blankets, consisting of one (1) pair Tayao for 24 hours or fraction thereof - **P250.00** and an additional **Twenty (20) pesos** for every hour thereafter.

Provided however, that for students / school organizations / associations, the rates shall be: for 24 hours or fraction thereof - P50.00 and an additional Five (P5.00) Pesos for every hour thereafter.


SECTION 2. Any ordinance, resolutions, administrative orders and other issuances inconsistent with the provisions of this ordinance are hereby repealed, cancelled and/or revoked;

SECTION 3. This ordinance shall take effect in accordance with the provisions of the Local Government Code of 1991.
