PROVINCIAL ORDINANCE NO. 99 - 51

AN ORDINANCE BANNING PRACTICE DRIVING, PASTURING LIVESTOCK AND HORSEBACK RIDING WITHIN THE PROPOSED SPORTS COMPLEX AT STOCKFARM, WANGAL, LA TRINIDAD, BENGUET

EXPLANATORY NOTE

In a letter of Mr. Jerome K. Nabus, dated September 9, 1998, Principal of Benguet National High School at Stockfarm, Wangal, La Trinidad, which was addressed to the Provincial Governor, requested for the passage of an ordinance totally banning practice driving and grazing activities at the Government Center, particularly within the proposed Sports Complex at Stockfarm, Wangal, La Trinidad, Benguet.

It was observed that these activities adversely affect and exposed students to hazards especially during their CAT, Field Works and sports activities. Further, with the proliferation of animals within the area, not only the tract oval becomes a mess but the school gardens as well are being destroyed.

BE IT ORDAINED BY THE SANGGUNIANG PANLALAWIGAN, IN SESSION ASSEMBLED, THE FOLLOWING:

SECTION 1. Ban on Practice Driving – It shall be unlawful for any person to conduct / perform and/or cause to conduct / perform practice driving activity within the proposed Sports Complex at Wangal, La Trinidad, Benguet ;

SECTION 2. Ban on Pasturing Livestock and Horseback Riding Activities- It shall likewise be unlawful for any person who, without permission from the authorities concerned, shall pasture livestock, conduct / perform horseback riding activities and / or cause to pasture livestock, cause to conduct / perform horseback riding activities within the proposed Sports Complex at Stockfarm, Wangal, La Trinidad, Benguet.

SECTION 3. Penalties - any person violating the above provisions referred to under Sections 1 and 2 hereof shall be fined the amount :












First Offense.....P 500.00
Second Offense.....1,000.00
Third and subsequent Offense.....3,000.00

Provided that in case the offender is a corporation, partnership or association, the officers and directors thereof shall be liable.


SECTION 4. If any part or provisions of this Ordinance shall be declared unconstitutional or invalid, the other provisions shall remain to be valid and effective.


SECTION 5. All ordinances, rules and regulations or part thereof inconsistent with or repugnant to with the provisions of this ordinance are hereby repealed, amended, or modified accordingly.


SECTION 6. This ordinance shall take effect in accordance with the provisions of the Local Government Code of 1991.
