PROVINCIAL ORDINANCE NO. 99 - 52

AMENDING SECTION 3 OF ORDINANCE NO. 97-39, DATED AUGUST 28, 1997 ENTITLED: "AN ORDINANCE PROVIDING FOR THE CREATION OF THE PROVINCIAL EQUIPMENT MANAGEMENT AND SERVICES OFFICE (PEMSO)"

Be it ordained by the Sangguniang Panlalawigan in session assembled that;

Section 1 - Section 3 of Provincial Ordinance No. 97-39 entitled: "An ordinance providing for the creation of the Provincial Equipment Management and Services Office (PEMSO)" is amended to read, viz:

"Section 3. The management and operation of the equipments shall be under the full control and supervision of the Provincial Governor. He shall be assisted by the Provincial Equipment Management and Services Office to consist of such Heads of Department Office, the Governor finds necessary, but without additional compensation.

The Provincial Governor shall appoint a chief Public Utility Regulation Officer who shall be a member of the PEMS0, with a compensation equivalent to that of G-24, equal to an Asst. Department Head, and all other employees and personnel necessary and required for the productive and efficient operation of the EQUIPMENT, in accordance with Civil Service Laws, Rules and Regulations.

Section 2 - This ordinance shall take effect in accordance with the provisions of the Local Government Code of 1991.


