**PROVINCIAL ORDINANCE NO. 99-57**

**AN ORDINANCE GRANTING ADDITIONAL COMPENSATION (ADCOM) TO PROVINCIAL OFFICIALS AND EMPLOYEES WITH SALARY GRADE 26 AND ABOVE**

**WHEREAS**, the Department of Budget and Management issued Budget Circular No. 17 dated February 24, 1999 extending the grant of P500.00 per month Additional Compensation (ADCOM) to Government Personnel allocated to Salary Grade 26 and above;

**WHEREAS**, the purpose of this Circular is to formalize the existing policies and rates governing the grant of P500.00 monthly ADCOM pursuant to Administrative Order (AO) 53 and to extend its grant to the rest of the personnel of the National Government, government owned and controlled corporations, government financial institutions, and LOCAL GOVERNMENT units as authorized under Section 49 of the General Provisions of RA No. 8745, the 1999 General Appropriations Act;

**WHEREAS**, among those covered by this circular are officials and employees of Local Government Units under paragraph 2.3, National and Local elective officials under paragraph 2.5 of this circular and others;

**WHEREAS**, exempted from the coverage, are those who have been declared absent without leave (AWOL) by competent authority and those under service contracts;

**WHEREAS**, UNDER PARAGRAPH 5.3 of this circular, Local Government Units shall source out funds from their respective local funds subject to PS limitation as provided under Section 325 of RA 7160;

**NOW THEREFORE, on motion of Hon. Liso L. Agpas duly seconded,**

**SECTION 1 -** An Additional Compensation (ADCOM) of P500.00 per month shall be granted to Provincial Officials and Employees with allocated Salary Grade 26 and above.

**SECTION 2 -** Provincial Officials and Employees who have been declared absent without leave (AWOL) by competent authority and those under service contracts shall be exempted from the coverage of this ordinance.

**SECTION 3 -** The amount of P148,500.00 is hereby appropriated for the purpose to be taken from the savings in prior years obligations.

**SECTION 4 -** This Ordinance shall take effect retroactive January 1, 1999.




