PROVINCIAL ORDINANCE NO . 99-59

GRANTING INFLATIONARY ADJUSTMENT ALLOWANCE TO ALL OFFICIALS AND EMPLOYEES OF THE PROVINCIAL GOVERNMENT OF BENGUET IN THE AMOUNT OF P7,200.00

WHEREAS, citing fiscal autonomy, the legislative and judicial department of the national government granted Inflationary Adjustment Allowance to its officials and employees;

WHEREAS, the present economic crises is a nationwide experience, thus employees of the Province of Benguet likewise need all the assistance they can get to weather the present economic storm brought about by the jacked up prices of gasoline and crude oil;

WHEREAS, Section . 468, (viii) of Republic Act No. 7160 otherwise known as the Local Government Code of 1991 provides that;

“Section 468. Powers, duties, Functions and Compensation. – (a) The Sangguniang Panlalawigan, as the legislative body of the province, shall ...

(viii) Determine the positions and the salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly or mainly from provincial funds ...”

WHEREAS, the grant of Inflationary Adjustment Allowance will ease the financial burden of employees and officials particularly during this time of economic difficulty and encourages extraordinary efforts and achievements in the performance and delivery of public service;

WHEREAS, the grant of Inflationary Adjustment Allowance is a timely expression of unwavering support and obligation to government service and a small price to pay for well-motivated, efficient and responsible civil servants and it boosts the sagging morale of government employees reeling from the effects of inflation;

NOW THEREFORE, on motion duly seconded, be it

Enacted by the Sangguniang Panlalawigan in Session Assembled the following:

SECTION 1 - Inflationary adjustment allowance herein granted shall be payable to officials and employees who have rendered at least a total of 4 months of service and still in the service as of December 15, 1999, whether appointive, or elective, permanent or casual, temporary, contractual whose employment is in the nature of a regular personnel, in the amount of Seven Thousand Two Hundred (P7,200.00) Pesos, as follows:

<u>Length of Service</u>	<u>Percentage</u>
4 months and above	100%
Less than 4 months but more than 3 months	75%
Less than 3 months but more than 2 months	50%
Less than 2 months but more than 1 month	25%

SECTION 2 - Provincial Officials and Employees who have been serving meted penalties unless, in the case of administrative charges, the penalty imposed is only reprimand and those who are absent without leave (AWOL) shall be exempted from the coverage of this ordinance.

SECTION 3 - The amount of **P6,076,800.00** is hereby appropriated for the purpose to be taken from the savings from operations of all offices from previous years and the current year under the General Fund.

SECTION 4 - This Ordinance shall take effect upon its approval.


