PROVINCIAL TAX ORDINANCE NO. 00 - 65

AMENDING PROVINCIAL TAX ORDINANCE NO. 00-63 DATED MAY 10, 2000 ENTITLED: "AN ORDINANCE REGULATING AND FIXING THE RATE OF HOSPITAL CHARGES AND FEES IN THE BENGUET GENERAL HOSPITAL AMENDING FOR THE PURPOSE SECTION 1 OF THE PROVINCIAL TAX ORDINANCE NO. 97-32" BY ADDING THEREON CERTAIN ITEMS, TO WIT: "OTHER FEES", "ADDITIONAL WARD PROCEDURE FEES" AND "MORGUE FEES"

EXPLANATORY NOTE

The august Body enacted Provincial Tax Ordinance No. 00-63 dated May 10, 2000 entitled: "An ordinance regulating and fixing the rate of hospital charges and fees in the Benguet General Hospital amending for the purpose Section 1 of the Provincial Tax Ordinance No. 97-32" This was published as required by law in the newspaper and that the public hearing and three readings were all conducted. However, other charges or fees are not included but which has to be regulated, such as: "Other Fees", "Additional Ward Procedure Fees" and "Morgue Fees".

Be it enacted by the Sangguniang Panlalawigan in Session Assembled that:




