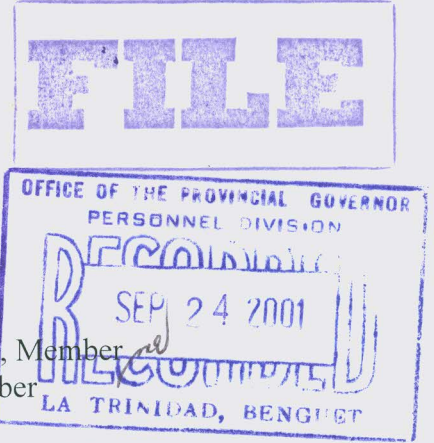

AN ORDINANCE CREATING TWO POSITIONS OF
CONSTRUCTION AND MAINTENANCE MAN UNDER
THE PROVINCIAL ENGINEER'S OFFICE

EXPLANATORY NOTE

Under Resolution No. 99-263 dated May 19, 1999 the SP approved the conversion of the Diboong-Bangao Barangay road in the municipality of Kabayan into a Provincial road. With the conversion, the Provincial Engineer requested that the position of two (2) Construction and Maintenance Men be created to be assigned at the said road since they can not pull out the other maintenance man overlooking other provincial roads.

Henceforth, as sponsored by Hon. Crescencio C. Pacalso, and on motion duly seconded,

BE IT ORDAINED BY THE SANGGUNIANG PANLALAWIGAN IN
SESSION ASSEMBLED THAT:

Section 1. The two (2) positions of Construction and Maintenance Man be created to be assigned at the newly converted Diboong-Bangao Provincial Road in the municipality of Kabayan, Benguet.

Section 2. That the said positions be added to the plantilla of the Provincial Engineer's Office and appropriations for the said positions be included in the budget for CY 2002.



Section 3. That this ordinance shall take effect immediately upon approval.


