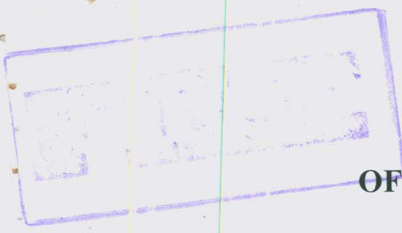

AN ORDINANCE AUTHORIZING THE VICE GOVERNOR TO **REALIGN** THE AMOUNT FROM THE UNEXPENDED BALANCE OF SALARIES TO RATA UNDER PERSONAL SERVICES (PS) THE AMOUNT OF P60,000.00 AND FROM PUBLICATION AND ADVERTISEMENT EXPENSES TO TELEPHONE SERVICES AND BOARD MEMBERS LEAGUE DUES UNDER MAINTENANCE AND OTHER OPERATING EXPENSES (MOOE) IN THE AMOUNT OF P40,500.00 UNDER THE SANGGUNIANG PANLALAWIGAN OFFICE.

EXPLANATORY NOTE

WHEREAS, due to the increase in number of Regular Members of the Sangguniang Panlalawigan, funds under certain items in the Current Budget are not sufficient to meet their corresponding funding requirements until the end of the year. These particular items with their respective estimated deficiencies are:

PERSONAL SERVICES:

Representation and Transportation Allowance (RATA) P 60,000.00

MAINTENANCE & OTHER OPERATING EXPENSES

Telephone Service P 20,000.00

Provincial Board Members League Dues P 20,500.00

ORDAINED BY THE SANGGUNIANG PANLALAWIGAN IN SESSION ASSEMBLED THAT:

Section 1. To authorize the Vice Governor Edna C. Tabanda to augment the amount of P60,000.00 from the Unexpended Balance of Salaries to RATA under Personal Services and the amount of P40,500.00 from Publication and Advertisements to Telephone Services and Board Members League Dues under MOOE all under the Sangguniang Panlalawigan Office.

Section 2. Effectivity. This ordinance shall take effect upon its approval.


