PROVINCIAL ORDINANCE NO. 02-81

AN ORDINANCE GRANTING EXTRA CASH GIFT OF FIVE THOUSAND (P5,000.00) PESOS TO ALL PROVINCIAL EMPLOYEES AND OFFICIALS

“WHEREAS, the Department of Budget and Management issued Budget Circular No. 2002-4 dated November 28, 2002 granting extra cash gift for CY 2002 which supercedes Budget Circular No. 2002-3 dated November 8, 2002;

WHEREAS, this benefit shall apply to all government personnel, whether elected, appointed in a permanent, temporary or casual status, including contractual personnel whose employment is in the nature of a regular employee, who are in the service as of October 31, 2002;

WHEREAS, the grant of Extra Cash Gift shall ease the financial burden of provincial government employees during this time of economic difficulty and impress upon them the spirit of sharing in this yuletide season;

WHEREAS, the Office of the Provincial Accountant certified to the availability of savings to cover the required amount;

NOW THEREFORE, on motion duly seconded,

BE IT ENACTED BY THE SANGGUNIANG PANLALAWIGAN IN SESSION
ASSEMBLED THAT:

Section 1. The Provincial Government of Benguet shall grant cash incentive to all officials and employees regardless of the status of appointment whose salary is charged against the general fund and who have rendered at least a total of 4 months of service and is still in the service as of October 31, 2002 in the amount equivalent to one month salary plus five thousand (P5,000.00) pesos.

Coverage/Exemption

1. All government personnel whether appointive or elective, permanent, casual, temporary or contractual whose salary is charged to the general fund and is still in the service as of October 31, 2002;
2. Employees under special projects shall be charged against Special Projects appropriations..
3. Locally paid teachers shall be charged against the Special Education Fund fund.

Computation

The computation for the ~~ascash~~ cash incentive for officials and employees who have rendered less than four (4) months shall be as follows:

- a. 3 months but not less than 4 months ----- 40%
- b. 2 months but not less than 3 months ----- 30%
- c. 1 month but not less than 2 months ----- 20%
- d. less than one (1) month -----10%

Funding.

The funding requirement of the herein cash incentive shall be charged from the available savings from the Current Operating Expenditure under the General Fund in the total amount of Thirteen Million Nine Hundred Two Thousand Six Hundred Sixty Seven (P13,902,667.00) pesos.

Section 2. This ordinance shall take effect immediately upon its approval.
