AN ORDINANCE GRANTING COLLECTIVE NEGOTIATION AGREEMENT SIGNING BONUS OF FIVE (5) THOUSAND PESOS (P5,000.00) TO ALL PROVINCIAL EMPLOYEES AND OFFICIALS

WHEREAS, the Benguet Provincial Government Employees Association (BPGEA), a duly registered and accredited organization of provincial employees in the Provincial Government of Benguet, is duly recognized as the sole and exclusive bargaining agent for all employees of the provincial government;

WHEREAS, The Benguet Provincial Government (BPG) and the Benguet Provincial Government Employees Association (BPGEA) have entered into a Collective Negotiation Agreement (CNA) pursuant to Executive Order No. 180 dated June 1, 1987 and Civil Service Commission Memorandum Circular No. 55, series of 1990;

WHEREAS, the above cited Collective Negotiation Agreement was ratified by the Sangguniang Panlalawigan on September 25, 2002;

3.3.1 Those who were meted the penalty of suspension.

3.3.2 Those who have incurred leave without pay of more than fifteen (15) days within one year period immediately preceding the ratification of the CNA.




