PROVINCIAL TAX ORDINANCE NO. 04 -87

**AN ORDINANCE AMENDING SECTION 40 OF PROVINCIAL ORDINANCE NO. 01, S. 1993 RELATIVE TO TAX DISCOUNT FOR ADVANCE AND PROMPT PAYMENT OF REAL PROPERTY TAXES**

WHEREAS, a group of farmers, businessmen, contractors and concerned citizens of the Province forwarded a petition to this august Body appealing for the removal/condonation of the penalties on delinquent taxes;

WHEREAS, Section 276 and Section 277 of the Local Government Code allows the condonation or reduction of Real Property Tax and interest by the Sangguniang Panlalawigan for the succeeding year or years and the President of the Philippines for any year respectively;


WHEREAS, cognizance of the plights of our unfortunate constituents, this Body acted favorably on the above request;

WHEREAS, in fairness to those who have been religiously paying their taxes despite the hardships encountered, there is a need to provide incentives for diligent taxpayers;

**NOW THEREFORE, BE IT ENACTED BY THE SANGGUNIANG PANLALAWIGAN THAT:**

**Section 1.** Amendment. Section 40 of Provincial Ordinance No. 01, s. 1993, Tax Discount for Advance and Prompt Payment, is hereby amended as follows:

- (a) Fifteen Percent (15%) on the tax due for prompt payment; and
- (b) Twenty Percent (20%) on the tax due for advance payment. Provided, however, that the tax discount herein authorized shall only be granted to taxpayers without any delinquency or whose accrued delinquencies are paid simultaneously with the tax due before the expiry date of the quarter.






Section 2. Period of Application. The above special tax discount for advance and prompt payment shall be applicable for a period of five (5) years covering the years 2004 to 2008.

Section 3. EFFECTIVITY. This Ordinance shall take effect upon its approval.


