PROVINCIAL ORDINANCE NO. 04-95

AN ORDINANCE REQUIRING THAT ALL CONTRACTS ENTERED INTO BY THE PROVINCIAL GOVERNOR REPRESENTING THE PROVINCIAL GOVERNMENT OF BENGUET SHALL BE RATIFIED BY THE SANGGUNIANG PANLALAWIGAN OF THE PROVINCE

EXPLANATORY NOTE

WHEREAS, Republic Act 9184 entitled: “An Act providing for the modernization, standardization and regulation of the procurement activities of the government and for other purposes”, was passed on December 18, 2002;

WHEREAS, said law covers the procurement process in the National Government, State Colleges and Universities, Government – Owned or Controlled Corporations and the LOCAL GOVERNMENT UNITS in order to attain the principles of transparency, competitiveness, streamlining the procurement process, system of accountability and public monitoring;

WHEREAS, in the composition of the Bids and Awards Committee (BAC) for Local Government Units under Rule V, Section 11.22 of Republic Act 9184, only personnel occupying plantilla positions of the procuring entity are qualified to be members which in effect amended Section 364 of Republic Act 7160 and Article 183 of its Implementing Rules and Regulations mandating as one of members the chairman of the Appropriations Committee in the Sanggunian;

WHEREAS, the only means by which check and balance be exercised due to this development is the ratification of all contracts entered into by the Provincial Governor, representing the Provincial Government of Benguet; and

WHEREAS, the contracts should be executed or implemented only after the ratification by the Sangguniang Panlalawigan of Benguet as a measure and safeguard for complete and effective implementation of projects;

NOW THEREFORE, on motion of Honorables Liso L. Agpas, Sario M. Copas, Fernando M. Arिताo, Marciano T. Inso, Sr., Johnny S. Uy, Juan M. Nazarro, Jr. and Apolinario T. Camsol, duly seconded.

Be it enacted by the Sangguniang Panlalawigan, Province of Benguet, in session duly assembled:


SECTION 1. RATIFICATION. That all contracts entered into by the Provincial Governor representing the Provincial Government of Benguet shall be ratified by the Sangguniang Panlalawigan of the Province and that said contracts will only be implemented or executed upon ratification by the august Body.


SECTION 2. CONTRACTS COVERED BY THE ORDINANCE. The ordinance shall cover among others the following contracts:


1. The 20% Provincial Development Fund (PDF);
2. Calamity Funds;
3. Special Education Fund; and
4. Other contracts involving transactions of the Province.


SECTION 3. EFFECTIVITY CLAUSE. This Ordinance shall take effect immediately upon its approval.




