PROVINCIAL ORDINANCE NO. 05-102

AN ORDINANCE CREATING A POLICY RESEARCH PROGRAM AND APPROPRIATING FUNDS THEREFOR

EXPLANATORY NOTE

“WHEREAS, the members of the Sangguniang Panlalawigan translate their governance policies through legislation covering the socio-economic, administrative, managerial and political development for the Province of Benguet;

WHEREAS, in order to legislate appropriate and effective governance policies, the Members of the Sangguniang Panlalawigan must do a comprehensive and thorough analyzed context of their proposed legislation through technically prepared policy researches;

WHEREAS, the Sangguniang Panlalawigan Office does not have sufficient personnel to assist and conduct research for the members of the Sangguniang Panlalawigan;

WHEREAS, cognizant of the need for thoroughly prepared government policies, the members of the Sangguniang Panlalawigan must provide a funding for it;

NOW THEREFORE, on motion duly seconded,

BE IT ORDAINED BY THE SANGGUNIANG PANLALAWIGAN IN SESSION ASSEMBLED THAT:

Section 1. A Policy Research Program (PRP) is hereby created;

Section 2. The purpose and guidelines in the use of the policy Research Program (PRP), as follows:

- a. The PRP shall be used for the conduct of studies and researches in aid of legislation;
- b. Each member of the Sangguniang Panlalawigan shall be allotted an amount equitable per month;

Handwritten signatures in blue ink, including a large signature at the top and several smaller ones below, likely representing the members of the Sangguniang Panlalawigan.

Handwritten initials and marks at the bottom of the page, including a large 'A' and several other scribbles.

- c. The PRP may be used to defray expenses in the conduct of community consultations, dialogues, focus group discussions and/or workshops. It may also be used in engaging the services of professional policy researchers;
- d. The research shall be the basis of proposed resolutions, ordinances and committee or special reports which should be collated and submitted together with all the receipts of expenses at the end of the year to be able to avail of the PRP for the following year;
- e. The Presiding Officer of the Sangguniang Panlalawigan shall approve request for the release of the PRP Fund, preferably on a monthly basis;

Section 3. Source of Fund. An amount shall be appropriated for this purpose to be drawn from any available amount in the General Fund to be incorporated in an appropriation ordinance;

Section 4. All provincial ordinances or parts thereof in conflict herewith are hereby amended, repealed or modified accordingly;


Section 5. This ordinance shall take effect in accordance with the provisions of the Local Government Code of 1991.
