PROVINCIAL ORDINANCE NO. 05-108

AN ORDINANCE ALLOWING PRIVATE PRACTICE OF MEDICINE AND PARAMEDICAL PROFESSIONALS AT THE BEGH AND DISTRICT HOSPITALS OF BENGUET AND ADOPTING IN TOTO THE REVISED POLICIES AND GUIDELINES ON THE PRIVATE PRACTICE OF MEDICAL AND PARAMEDICAL PROFESSIONALS IN GOVERNMENT HEALTH FACILITIES UNDER A.O. 92 AS AN INTEGRAL PART HEREOF

WHEREAS, the Secretary of Health issued Administrative Order No. 92 s. 2003 on September 22, 2003, setting the Revised Policies and Guidelines on the Private Practice of Medical and Paramedical Professionals in Government Health Facilities repealing Administrative Order No. 172 s. 2001 which was issued by the Department on January 09, 2001;

WHEREAS, the rationale of allowing medical and paramedical personnel to engage in private practice serves as an incentive and in recognition of their commitment to remain as members of the hospital staff for a longer period to bring about continuous quality improvement of the health care delivery service of the facility as well as to attract the best and the brightest professionals for medical and paramedical positions not to mention the expected benefits in allowing private practice of government medical and paramedical personnel in government hospitals and other health facilities;

NOW THEREFORE, be it ordained in session assembled that:

Section 1 – Private practice of Medical and Paramedical Professionals at the Benguet General Hospital and District Hospitals of the Provincial Government of Benguet, as may be applicable is hereby allowed and adopting in toto the provisions of Administrative order No. 92 issued by the Department of Health providing Revised Policies and Guidelines attached hereof as integral part of the ordinance;

Section 2 - This shall cover the private practice of all government salaried physicians and paramedical professionals involving private patients in private rooms at the Benguet General Hospital as may be applicable;

Section 3 - The Hospital Board of Directors in consultation with the Philippine Medical Association and respective Societies and Hospital Staff shall determine the appropriate professional fees to be charged to patients at the hospital subject to the concurrence of the Sangguniang Panlalawigan;

Section 4 – An amount equivalent to five per centum (5%) of the professional fee be retained by the hospital to cover the cost of light, water, supplies and the use of facilities in providing the service and ten per centum (10%) of the professional fee be withheld by the hospital to be remitted to the Bureau of Internal Revenue representing Value Added Tax imposed under R.A. 9337;

Section 5 – A representative from the Sangguniang Panlalawigan preferably the Chairman of the Committee of Health shall be a member of the accreditation committee;

Section 6 – Any violation of the provision of the Ordinance shall be a ground for administrative sanction;

Section 7 – All existing ordinances and issuances inconsistent with this Ordinance are deemed amended or repealed accordingly;

Section 8 – This Ordinance shall take effect on January 1, 2006.


