PROVINCIAL ORDINANCE NO. 07-114

AMENDING SECTIONS 6 & 8 OF PROVINCIAL ORDINANCE NO. 06-113
AN ORDINANCE AMENDING THE IMPLEMENTING GUIDELINES
PRESCRIBED FOR THE MANAGEMENT AND OPERATION OF THE
BENGUET COLD CHAIN PROJECT

WHEREAS, presented for deliberation of the august Body is letter dated November 21, 2006 of Shellanie Biang –Molitas, Project Manager of the Benguet Cold Chain Project requesting for reconsideration on Provincial Ordinance No. 06-113 amending implementing guidelines prescribed for the management and operation of the Benguet Cold Chain Project

WHEREAS, the august Body finds the recommended amendments beneficial to the operation of the Benguet Cold Chain Project;

On motion duly seconded,

BE IT ORDAINED BY THE SANGGUNIANG PANLALAWIGAN IN SESSION ASSEMBLED THAT:

Section 1 – Section 6 of Provincial Ordinance No. 06-113 is hereby amended to read as follows:

“**Section 6. Project Management Committee** – There shall be established a committee of thirteen (13) composed of the Provincial Governor as Chairman; An Executive Assistant to the Governor as Vice Chairman, and as members Two (2) representatives from the Sangguniang Panlalawigan, specifically the Chairman of the SP Committee on Finance and the Chairman of the SP Committee on Agriculture; The President of the League of Municipalities of Benguet; The President of the Philippine Councilor’s League-Benguet Chapter; One (1) representative from the Provincial Agriculturist’s Office; Two (2) representatives from the Benguet Farmer’s Federation; Inc. One (1) representative from the Bureau of Post-Harvest Research and Extension; One (1) representative from the Department of Agriculture-CAR; One (1) representative from the DTI-Benguet; and One (1) representative from the Benguet Chamber of Commerce”

Section 2- Section 8 of Provincial Ordinance No. 06-113 is likewise amended to read as:

“**Section 8. Fees and Collections-** There shall be various fees to be collected on the following facilities to be rented out such as the following;

- a) 20-footer refrigerated truck – Five Thousand Six Hundred Pesos (P5,600.00) with a load not exceeding 5,000 kilograms;
- b) 16-footer refrigerated truck –Three Thousand Five Hundred Pesos (P3,500.00) with a load not exceeding 3,900 kilograms; and
- c) 10-footer refrigerated truck –Three Thousand Pesos (P3,000.00) with a load not exceeding 1,950 kilograms.”

Section 3. This ordinance shall take effect immediately upon its approval.




