PROVINCIAL ORDINANCE NO. 07-115

AN ORDINANCE GRANTING TAX RELIEF ON THE INTEREST AND SURCHARGES ON REAL PROPERTY TAXES IN THE PROVINCE OF BENGUET

“WHEREAS, due to the adverse economic conditions of our country, aggravated by calamities, low prices of farm produce and increase in power and oil prices experienced by the people of Benguet, many of our constituents failed to pay their real property taxes last year and previous years;

WHEREAS, on December 11, 2006, the august Body passed Resolution No. 06-337 granting tax amnesty on interests and surcharges of Real Property Taxes for the previous years in the Province of Benguet effective until June 30, 2007;

WHEREAS, there is a need to formalize said amnesty through the passage of an ordinance putting the same into effect;

**ORDAINED BY THE SANGGUNIANG PANLALAWIGAN OF THE PROVINCE OF BENGUET IN SESSION ASSEMBLED, THAT:**

**Section 1.** The Province of Benguet is granting tax relief on interest and surcharges of Real Property taxes for the year 2006 and previous years ;

**Section 2.** To avail of the tax amnesty on penalties, surcharges and interest, the delinquent tax payers should pay the whole tax due (Basic & SEF ) up the current year;

**Section 3.** The tax amnesty herein granted may be availed of until June 30, 2007 only. In cases where the taxpayers fail to avail of the amnesty, the real property tax delinquencies due on the subject property shall remain at their original values plus the penalty imposed thereon;

**Section 4.** That no public auction of delinquent real properties shall be held during the period of amnesty;

**Section 5.** The tax amnesty shall not apply to any of the following;

- a) Real properties which have been disposed off at public auction to satisfy tax delinquencies;
- b) Real properties subject of pending cases in court for real property tax delinquencies;
- c) Real properties, the payment of tax delinquencies of which are subject to existing compromise agreement;


**Section 6.** No refund shall be given to those who have already paid their penalties.

**Section 7.** All provincial ordinances or parts thereof in conflict herewith are hereby amended, repealed or modified accordingly;

**Section 8.** This ordinance shall take effect on January 1, 2007.
