PROVINCIAL ORDINANCE NO. 07-119

**EXTENDING THE DEADLINE OF TAX RELIEF UNDER PROVINCIAL ORDINANCE NO. 07-115 FROM JUNE 30, 2007 TO DECEMBER 31, 2007 AMENDING THEREFORE SECTION 3 OF PROVINCIAL ORDINANCE NO. 07-115**

**“WHEREAS**, the Sangguniang Panlalawigan passed Provincial Ordinance No. 07-115- granting tax relief on interests and surcharges on real property in the province of Benguet;

**WHEREAS**, the ordinance was passed to ease the economic pressure being experienced by the constituency as a result of the adverse economic conditions of our country;

**WHEREAS**, Provincial Ordinance No. 07-115 provides that the tax relief can only be availed of until June 30, 2007 ;

**WHEREAS** , the Body received various requests appealing for the extension of the deadline of the tax amnesty as provided in the Provincial Ordinance from June 30, 2007 to December 30, 2007;

**WHEREAS**, the body finds the request meritorious and justifiable;

**On motion of Hon. Apolinario T. Camsol, duly seconded, be it**

**ORDAINED BY THE SANGGUNIANG PANLALAWIGAN OF THE PROVINCE OF BENGUET IN SESSION ASSEMBLED, THAT:**

**Section 1.** The period to avail of the tax relief on interest and surcharges of Real Property Taxes is hereby extended from June 30, 2007 to December 31, 2007 with no further extensions;

**Section 2.** This ordinance takes effect immediately upon approval.
