**PROVINCIAL TAX ORDINANCE NO. 07-121**

**IMPOSING FEES FOR BID FORMS AND OTHER BID DOCUMENTS  
REQUIRED BY THE BIDS AND AWARDS COMMITTEE**

**EXPLANATORY NOTE**

**WHEREAS**, presented to the august body are proposed fees for bid forms and other bid documents required by the Bids and Awards Committee for Infrastructure and for Goods and Services;

**WHEREAS**, Section 132 of the Local Government Code provides that “the power to impose a tax, fee, or charge or to generate revenue under this Code shall be exercised by the sanggunian of the local government unit concerned through an appropriate ordinance;

**WHEREAS**, the appropriate public hearing was conducted in connection with this ordinance;

**NOW, THEREFORE**, on motion duly seconded, be it

**ORDAINED BY THE SANGGUNIANG PANLALAWIGAN OF  
BENGUET, IN SESSION ASSEMBLED, THAT:**

**Section 1. Imposition of Fees.**—There shall be fees to be collected for bid documents required by the Provincial Bids and Awards Committee for Infrastructure and for Goods and Services, as follows:

**Section 2. Time and Manner of Payment.**—The fees imposed shall be paid in full to the Provincial Treasurer or his authorized representative at the time of purchase of the eligibility and bid forms.


**Section 3. Separability Clause.**—If, for any reason, any section or provision of this ordinance shall be held to be unconstitutional or invalid by competent authority, such judgment or action shall not affect or impair the other provisions or sections hereof.

**Section 4. Applicability Clause.**—All other matters relating to the imposition in this ordinance shall be governed by pertinent provisions of existing laws and other ordinances.


**Section 5. Repealing Clause.**—All ordinances, resolutions, executive orders, rules and regulations, or part thereof in conflict with or inconsistent with any provision of this ordinance are hereby repealed or modified accordingly.

**Section 6. Effectivity Clause.**—This ordinance shall take effect in accordance with the provisions of the Local Government Code of 1991.






