PROVINCIAL ORDINANCE NO. 08-125

AN ORDINANCE CREATING VARIOUS CAREER POSITIONS IN VARIOUS OFFICES OF THE PROVINCIAL GOVERNMENT OF BENGUET

EXPLANATORY

WHEREAS, the Province of Benguet is rapidly growing in terms of its programs and priorities as to General Public Services; Health, Nutrition and Population Control; Social Services and Welfare; Economic Services; and Other Services;

WHEREAS, there is a need to create new positions in the different offices as they are needed to facilitate the fast delivery of public services;

NOW THEREFORE, on motion duly seconded, be it

ORDAINED BY THE SANGGUNIANG PANLALAWIGAN IN SESSION ASSEMBLED THAT:

Section 1. The following are the career positions which are created in the different offices of the Provincial Government of Benguet, to wit;

A. Provincial Governor's Office - Main:

- i. 1 Administrative Officer II, G-11; 1 Administrative Aide V (Chauffeur), G-5; 1 Administrative Aide III (Utility Worker II), G-3; Administrative Aide IV, G-4 (Tourism Office); and 1 Administrative Aide III (Driver I), G-3, (Tourism Office)

B. Provincial Governor's Office - Jail:

- i. 1 Administrative Officer I, G-10; and 1 Prison Guard III, G-10.

C. Provincial Governor's Office - ENR:

- i. 1 Engineer III, G-19; and 1 Senior Environmental Management Specialist, G-18.

D. Provincial Planning and Development Office (7 positions created from the existing wages' appropriation);

- i. 4 Engineering Assistants, G-8; 1 Draftsman II, G-8; 1 Administrative Aide III, G-3 and 1 Administrative Aide III (Driver I), G-3.

E. Provincial Budget Office:

- i. 1 Administrative Aide VI, G-6; 1 Administrative Aide III (Driver I), G-3; and 1 Administrative Aide I (Utility I), G-1.

 - i. 1 Rural Health Physician, G-24; 1 Nurse II, G-14; 1 Nutritionist II, G-14; 1 Dentist II, G-16; 1 Sanitary Inspector IV, G-13; and 1 Dental Aide, G-4.
 - ii. And create the following positions for Benguet General Hospital Economic Enterprise (BeGHEE), to wit:
 - 1 Medical Officer IV (ER Physician), G-20; 1 Nurse II, G-14, 1 Administrative Aide IV (Inventory Clerk), G-4; and 3 Administrative Aide III (Cash & Billing Clerks), G-3.

Section 2. This ordinance shall take effect upon its approval.


