**PROVINCIAL TAX ORDINANCE NO. 08-126**

**AN ORDINANCE AMENDING SECTION 104 OF THE PROVINCIAL TAX ORDINANCE NO. 05-107 DATED DECEMBER 5, 2005 OF THE PROVINCE OF BENGUET**

**EXPLANATORY NOTE**

**WHEREAS**, the Sangguniang Panlalawigan of Benguet enacted Provincial Tax Ordinance No. 07-122, dated November 5, 2007 amending Section 104 of the Provincial Tax Ordinance No. 05-107 but was not approved due to non-compliance with the mandatory requirement of a public hearing as enunciated by Section 187, Republic Act No. 7160, otherwise known as the Local Government Code of 1991, as amended;

**WHEREAS**, Section 104 of Provincial Ordinance No. 05-107 dated December 5, 2005, otherwise known as the Revenue Code of the Province of Benguet vests in the Province of Benguet the discretion to offer other courses in addition to those listed therein and may impose necessary increases of tuition fees as determined by the Sangguniang Panlalawigan in an annual basis;

**WHEREAS**, the aforesaid increase in tuition and other fees at the Benguet Technical School is fair and reasonable and will further enhance the capability of the School in the delivery of quality education; and

**WHEREAS**, the aforesaid Section 104 of Provincial Ordinance No. 05-107 provides the courses with the corresponding fees, to wit:




