**PROVINCIAL ORDINANCE NO. 08-127**

***CREATING THE AWARDS COMMITTEE FOR THE YEARLY  
FOUNDATION ANNIVERSARY OF THE PROVINCE OF BENGUET***

**EXPLANATORY NOTE**

**WHEREAS**, the yearly Benguet Foundation Anniversary is being celebrated in the month of November;

**WHEREAS**, one of the main highlights of the yearly event is the giving of Plaques of Recognition and Certificates of Appreciation to individuals, entry or entity who demonstrated qualities of leadership in any field with outstanding achievements/accomplishments, rendered social, economic and infrastructure services benefitting/projecting a good image for the province internationally, nationally or regionally;

**NOW THEREFORE, on motion duly seconded,**

**BE IT ORDAINED BY THE SANGGUNIANG PANLALAWIGAN OF BENGUET THAT:**

**Section 1. There shall be created an Awards Committee to be composed of the following:**

**Chairman** : Provincial Governor  
**Vice Chairman** : Provincial Vice Governor  
**Members** :

1. The President/Chairman - Philippine Public School Teachers Association;
2. The President/Chairman - Benguet Provincial Government Employees Association;
3. SP Secretary;
4. SP Committee Chairman on Personnel Administration;
5. SP Committee Chairman on Youth Development;
6. Provincial Social Welfare and Development Office;
7. Representative from former Benguet Leadership Awardee;
8. NGO from Women Sector;
9. NGO from Agriculture Sector;



10. NGO – other Sector (to be chosen by the members of the Awards Committee)  
**Secretariat** : Ms. Rosaline Q. Elayda

**Section 2. Functions of the Awards Committee:**

1. To prepare guidelines for nomination;
2. To select awardees in various categories after proper verification;
3. To prepare write-ups;
4. To coordinate the preparation of plaques with the Provincial General Services Officer; and
5. To present lists of proposed awardees to the Governor and Sangguniang Panlalawigan for their approval and/or appropriate action.

**Section 3. Criteria for each Category of Award:**

**A. Benguet Leadership Awards:**

1. Awardee must be a native born citizen of the Province.
2. Awardee must have demonstrated qualities of leadership in any field with outstanding achievements/accomplishments projecting a good image for the province internationally, nationally or regionally.
3. Awardee must be a living individual.
4. Awardee must not have previously been given the same category of award by the province.
5. Must not be incumbent elective official of the province.

**B. Everlasting Award:**

1. Awardee may either be an individual or an entry.
2. Awardee must have voluntarily rendered social, economic and infrastructure services benefitting the province or two or more municipalities and/or its people.
3. Awardee must not have previously been given the same category of award.

**C. Achievement Awards:**

1. Awardee may be either living or dead individual or an entry.
2. Awardee must have done outstanding action worthy of emulation in a specific field of endeavor thus projecting a good image for the province or the people of Benguet regionally, nationally or internationally.
3. A native born or resident/domicile of the province for at least ten (10) years.
4. Must not have previously been given the same category of award.

**D. Outstanding Student Leadership Award:**

1. Awardee must be a living individual and currently enrolled in any school;
2. Awardee must be a native born of the province;
3. Awardee must have demonstrated qualities of leadership in any field with outstanding achievements / accomplishments projecting a good image for the province internationally, nationally or regionally; and
4. Awardee must not have previously been given the same category of award by the province.

**Section 4.** The Awards Committee shall present the lists of awardees within 45 days before the giving of awards subject to the approval of the Sangguniang Panlalawigan.

**Section 5.** Per Diems or Honorarium shall be given to the Awards Committee Members who are non-government employees or officials subject to the usual accounting, auditing rules and regulations.

**Section 6.** A "18 Karat Gold Ring" and Plaque will be given to the Leadership Awardee. For Everlasting Awardee, Achievement Awardee and Outstanding Student Leadership Awardee, a plaque of appreciation will suffice.

**Section 7.** The date of the nomination should be published and announced through radio.

**Section 8. SOURCE OF FUND.** The total amount of One Hundred Fifty Thousand Pesos (P150,000.00) is hereby made available every Calendar Year in the General Fund of the Province;

**Section 9. APPROPRIATION.** The amount of One Hundred Fifty Thousand Pesos (P150,000.00) herein made available annually is hereby appropriated for Per Diems, Rings and Plaques for the said activity;

**Section 10. EFFECTIVITY.** This ordinance takes effect upon approval.


