**APPROVING THE IMPLEMENTATION OF THE FIRST TRANCHE MONTHLY SALARY SCHEDULE FOR LOCAL GOVERNMENT PERSONNEL IN THE PROVINCE OF BENGUET**

**EXPLANATORY NOTE**

**WHEREAS, PRESIDENT GLORIA MACAPAGAL – ARROYO** approved Executive Order No. 811 dated June 17, 2009 "Adopting the First Tranche of the Modified Salary Schedule of Military and Uniformed and Base Pay Schedule of Military and Uniformed Personnel in the Government as well as the Modified Position Classification System pursuant to Senate and House of Representatives Joint Resolution No. 4, S. 2009;

**WHEREAS,** Section 2 (a) of the aforesaid Executive Order No. 811 partly provides that the Modified Compensation and Position Classification System shall cover all positions in the Local Government Units, whether regular, casual, or contractual in nature, appointive or elective, on full-time or part-time basis, now existing or hereafter created;

**WHEREAS,** Section 4 of the same Executive Order No. 811 provides that the First Tranche of Implementation for Local Government Units shall take effect January 1, 2010;

**WHEREAS,** Local Budget Circular No. 2009-92 dated September 3, 2009 prescribes the guidelines, rules and regulations to govern the implementation in Local Governments Units (LGU's) of the pertinent provisions of the aforesaid Joint Resolution and Executive Order No. 811;

**WHEREAS, Annex "A2" of the aforesaid Budget Circular No. 2009-92** providing for the First Tranche Monthly Salary Schedule for Local Government Personnel in Second Class Provinces and Cities effective January 1, 2010 is hereby adopted;

**NOW THEREFORE, BE IT ORDAINED BY THE SANGGUNIANG PANLALAWIGAN IN SESSION ASSEMBLED THAT:**
