PROVINCIAL ORDINANCE NO. 10 - 135

AN ORDINANCE FURTHER AMENDING SECTION 8 OF PROVINCIAL ORDINANCE NO. 07-114, "AN ORDINANCE AMENDING THE IMPLEMENTING GUIDELINES PRESCRIBED FOR THE MANAGEMENT AND OPERATION OF THE BENGUET COLD CHAIN PROJECT".

EXPLANATORY NOTE

WHEREAS, in year 2006 through Provincial Ordinance No. 07-114, amendments were introduced to the implementing guidelines for the Benguet Cold Chain Project;

WHEREAS, further amendments particularly to Section 8 of the aforementioned ordinance are necessary to coup up with existing costs of maintenance and repairs of the Benguet Cold Chain's facilities and equipment;

NOW THEREFORE, BE IT ORDAINED BY THE SANGGUNIANG PANLALAWIGAN IN SESSION ASSEMBLED THAT:

Section 1. Section 8 of Provincial Ordinance No. 07-114 is hereby amended to read as follows:

Modular Cold Storage Utilization – The Cold Storage with a maximum capacity of Five Thousand Kilograms per chamber shall be rented out on a Twenty Four (24) Hours duration as follows:</p> <p>a) Seven Hundred Pesos (P700) per chamber; and</p> <p>b) One Thousand Two Hundred Pesos (P1,200) for the Two chambers.</p>	<p>a.1 Rental Rates for Pure Leafy Vegetables:</p> <p>1. Transport Facility Utilization – the refrigerated trucks are rented out on a 24 hours duration normally from La Trinidad to Manila areas to La Trinidad with the following fees:</p> <p>a) 20 footer refrigerated truck – Six Thousand One Hundred Pesos (P6,100) with a minimum load of 4,500 kilograms and not exceeding 5,000 kilograms;</p> <p>b) 18 footer refrigerated truck – Five Thousand Pesos (P5,000) with a load not exceeding 4,000 kilograms;</p> <p>c) 16 footer refrigerated truck – Four Thousand Pesos (P4,000) with a load not exceeding 3,500 kilograms;</p> <p>d) 14 footer refrigerated truck – Three Thousand Seven hundred Fifty (P3,750) with a load not exceeding 2,000 kilograms; and</p> <p>e) 10 footer refrigerated truck – Three Thousand Five Hundred Pesos (P3,500) with a load not exceeding 1,950 kilograms;</p> <p>a.2 Rental Rates for Mixed Vegetables:</p> <p>f) 20 footer with load limit to 5 tons – P7,000;</p> <p>g) 18 footers with load limit of 4 tons – P6,000</p> <p>h) 16 footers with load limit of 3.5 tons – P5,000</p> <p>i) 14 footers with load limit of 2 tons – P4,000</p> <p>j) 10 footers with load limit of 1.95 tons – P3,500</p>


- k) The client shall however, shoulder the cost of fuel, toll fees and other incidental expenses;
- l) In the event that the 24-hours duration shall have lapsed during a normal situation, an additional charge shall be collected in proportion to the number of extended hours; (Rate/24 hrs. x 8.12
- m) Additional charges shall be collected for delivery and/or pick-up services beyond the boundaries of Manila which shall be determined by the excess of the regular and normal distance travelled. (Mla. - 256 km.)

IV. Cold Storage Utilization – The Cold Storage with a maximum capacity of Five Thousand (5,000kg) kilograms per chamber shall be rented out on a Twenty Four (24) Hours duration as follows:

- A. Modular Cold Storage:
 - a. Eight Hundred Pesos (P800) per chamber; and
 - b. One Thousand Four Hundred Pesos (P1,400) for the two Chambers.
- B. Reefer Container
 - a. One Thousand Pesos (P1,000)/day

Section 2. Effectivity. This Ordinance shall take effect in accordance with the provisions of the Local Government Code of 1991, as amended.
