AN ORDINANCE CREATING THE POSITIONS AT THE KAPANGAN MEDICARE COMMUNITY HOSPITAL AND ABATAN EMERGENCY HOSPITAL.

WHEREAS, presented to this Body are the requests of the Kapangan Medicare Community Hospital for the creation of One (1) Medical Officer IV, Salary Grade 23 and One (1) Radiologic Technologist II, Salary Grade 13 and One (1) Radiologic Technologist II, Salary Grade 13 at the Abatan Emergency Hospital;

WHEREAS, the said positions are already included in the Plantilla under the Annual Performance Budget of the Province of Budget for the Calendar Year 2010;

BE IT ORDAINED BY THE SANGGUNIANG PANLALAWIGAN OF BENGUET THAT:

SECTION 1. CREATION OF POSITIONS. The following positions are hereby created at the aforementioned hospitals:

2. One (1) Radiologic Technologist II, Salary Grade 13 at the Kapangan Medicare Community Hospital;
3. One (1) Radiologic Technologist II, Salary Grade 13 at the Abatan Emergency Hospital;


