**PROVINCIAL ORDINANCE NO. 10 - 137**

**AN ORDINANCE AMENDING SECTION 1 OF PROVINCIAL TAX ORDINANCE NO. 08-126 DATED MAY 26, 2008 IMPOSING FEES TO COURSES OFFERED AT THE BENGUET TECHNICAL SCHOOL (BTS) LOCATED AT WANGAL, LA TRINIDAD, BENGUET, TO INCORPORATE "NIHONGGO LANGUAGE" AS AN ADDITIONAL COURSE TO BE OFFERED AT THE SCHOOL AND PROVIDING THE CORRESPONDING FEES FOR THE PURPOSE.**

**EXPLANATORY NOTE**

**WHEREAS**, section 106 of the Benguet Revenue Code OF 2005 provides that "the Province may offer other courses in addition to the present courses offered at the Benguet Technical School (BTS) and may impose the necessary tuition fees and subsequent increases to be determined by the Sangguniang Panlalawigan on an annual basis";

**WHEREAS**, Section 1 of Provincial Tax Ordinance No. 08-126 amending section 104 of the Benguet Revenue Code of 2005, explicitly provided the titles and courses being offered at the Benguet Technical School (BTS) with the corresponding fees thereof;

**WHEREAS**, the incorporation of a Nihonggo Language classes at the Benguet Technical School is necessary to help facilitate the training of Benguet Farmer Trainees going to the prefectures and sister-provinces of Benguet in Japan;

**NOW THEREFORE, BE IT ORDAINED BY THE SANGGUNIANG PANLALAWIGAN ASSEMBLED THAT:**

**Section 1.** Section 1 of Provincial Tax Ordinance N. 08-126 shall be amended to read as follows:
