**ABOLISHING FOUR (4) POSITIONS AND IN ITS STEAD CREATING NEW FOUR (4) POSITIONS AT THE PROVINCIAL HEALTH OFFICE**

**WHEREAS**, a request for abolition of existing positions and consequent creation of alternate positions was made by Dr. Esteban T. Piok, Provincial Health Officer II, of the Provincial Health Office in his letter dated September 2, 2010 addressed to Hon. Governor Nestor B. Fongwan which the latter referred to the Provincial Finance Committee;

**WHEREAS**, acting on the referral, the Provincial Financial Committee recommended favorable action thereon thru its 1<sup>st</sup> Indorsement dated October 28, 2010 which was forwarded to this Body for appropriate action;

**WHEREAS**, after careful review of the request and the wisdom behind it, this Body is convinced that there is indeed a need for the abolition of items and the creation of new positions essential for the better operation of the Provincial Health Office;

**WHEREAS**, as to the proposed new position of 1 Administrative Aide I (Utility Worker I), SG-1, this Body prefers the upgraded position of 1 Administrative Aide III (Utility Worker II), SG-3 be created;
