**PROVINCIAL ORDINANCE NO. 11- 142**

**AN ORDINANCE CREATING VARIOUS CAREER POSITIONS IN THE LOCAL GOVERNMENT OF THE PROVINCE OF BENGUET**

**WHEREAS**, in the deliberation of the 2011 Annual Performance Budget of the Provincial Government of Benguet, the Governor proposed the creation of new positions for the Governor's Office (Main and Tourism) Provincial Planning and Development, Provincial Budget Office, Provincial Engineer's Office, Atok District Hospital and the Environment and Natural Resources Office. The latter office has two positions proposed for abolition and two new creations in its stead;

**WHEREAS**, as proposed, the Sanggunian approved the creation of positions with its eventual inclusion in the Budget bearing in mind the exigency of public service to meet the demands of growing clientele;

**WHEREAS**, for the Sangguniang Panlalawigan Office, the creation of four (4) positions is also in order;

**NOW THEREFORE**, on motion duly seconded,

**BE IT ORDAINED BY THE SANGGUNIANG PANLALAWIGAN IN SESSION ASSEMBLED THAT:**


