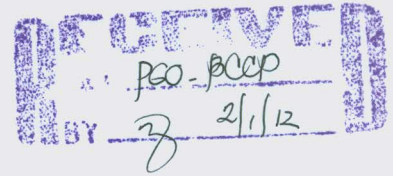

PROVINCIAL ORDINANCE NO. 11-152

AMENDING SECTION 8 OF PROVINCIAL ORDINANCE NO. 07-114 AND PROVINCIAL ORDINANCE NO. 04-97 PARTICULARLY ON FEES AND COLLECTIONS OF THE BENGUET COLD CHAIN PROJECT.

WHEREAS, presented to this august Body for its consideration is the 1st Indorsement dated September 30, 2011 transmitting letter dated September 26, 2011 of Ms. Shellanie B. Molitas, Administrative Officer of the Benguet Cold Chain Project relative to the proposed amendments of Provincial Ordinance No. 07-114 dated January 22, 2007 and Provincial Ordinance No. 04-97 dated November 17, 2004;

WHEREAS, the amendment of the aforesated Ordinance is advantageous to keep up with the present economic situation and to maximize the use of the Cold Chain;

NOW THEREFORE, on motion duly seconded

BE IT ORDAINED BY THE SANGGUNIANG PANLALAWIGAN IN SESSION ASSEMBLED THAT:

Section 1. – Section 8 of Provincial Ordinance Nos. 07-114 and 04-97 is hereby amended to read as:

Section 8. Fees and Collections. There shall be various **rental** fees to be collected on the following facilities.

- I. Refrigerated Trucks – the refrigerated trucks are rented out normally on a 24-hours duration from La Trinidad to areas within Metro Manila:

a.1. Rental Rates for Pure Leafy Vegetables are as follows:

Size of truck (feet)	Truck Rental
20	6,300.00
18	5,000.00
16	4,000.00
14	3,500.00
10	3,000.00

a.2. Rental Rates for Mixed Vegetables observing specific load limit per truck as follows:

Size of truck (feet)	Load limit (tons)	Rental (Php)
20	5	7,300
18	4	6,000
16	3	5,000
14	2	4,000
10	1.95	3,500

- b. The client shall however, shoulder the cost of fuel, toll fees, and other incidental expenses and shall provide a truck helper.
- c. In the event that the 24 hours duration shall lapse during a normal situation, an additional charge shall be collected in proportion to the number of extended hours:
- d. Additional charges shall be collected for delivery and/or pick up services beyond the boundaries of Metro Manila which shall be determined by the excess of the regular and normal distance traveled.
- e. Based on the rates above (a.1 and a.2), rental rates per reefer truck shall be increased by P500.00 per year for a period of three (3) years upon the effectivity of the ordinance.

II. Crates Utilization:

- d. In case of loss or total damage of crates, the borrower shall be required to pay the unit at Three Hundred Twenty Pesos (P320.00) per crate or replacement with the same quality;
- e. Maximum number of plastic crates to be rented out per client shall be:
- e.1. Equivalent to the full capacity of the reefer truck being rented; and/ or
- e.2 Equivalent to the full capacity of the storage space occupied.

e.3. Management however has the prerogative to rent out crates in excess of the limit stated above.

g. The crates shall be rented out exclusively for the packaging of vegetables.

III. Modular Cold Storage Utilization – The Cold Storage with a maximum capacity of Five Thousand Kilograms per chamber shall be rented out on a twenty four (24) hours duration as follows:

a. One Thousand Pesos (P1,000.00) per Chamber; and

b. Base on the foregoing rate, rental rates per chamber per day shall increase by P200.00 per year for a period of three (3) years upon the effectivity of the ordinance.

Section 2. - Section 9 of Provincial Ordinance Nos. 07-114 and 04-97 is likewise amended to read as:

Section 9. Payment of Fees – All fees shall be paid at the Provincial Treasurer's Office.

Section 3. This Ordinance shall take effect upon its approval.
