**PROVINCIAL ORDINANCE NO. 12-156**

**AN ORDINANCE CREATING VARIOUS CAREER POSITIONS IN THE LOCAL GOVERNMENT OF THE PROVINCE OF BENGUET**

**WHEREAS**, under Appropriation Ordinance Nos. 12-05 and 12-07 dated May 7, 2012 and May 28, 2012, there were several career positions which were proposed and funded for the different offices of the provincial government including positions which were created in lieu of some vacant positions under the PHO, Atok District Hospital and the Benguet General Hospital Economic Enterprise;

**WHEREAS**, under Supplemental Budget No. 10 dated September 10, 2010, another position was provided additional funding for the creation of an Administrative Aide III (Driver I) in lieu of the abolition of the existing vacated position of Administrative Aide I (Utility Worker) at the Provincial Legal Office;

**WHEREAS**, as proposed, the Sanggunian approved the creation and abolition of various career positions due to exigency of public service;

**NOW THEREFORE**, on motion duly seconded,

**BE IT ORDAINED BY THE SANGGUNIANG PANLALAWIGAN IN SESSION ASSEMBLED THAT:**

**Section 2.** Budgetary Allocation – the annual budgetary allocation of the created positions were already appropriated under Supplemental Budget No. 1 dated May 7, 2012 for Benguet General Hospital Economic Enterprise (BeGHEE), Supplemental Budget No. 5 dated May 28, 2012 and Supplemental Budget No. 10 dated September 10, 2012 for the other positions of various offices.

**Section 3.** Effectivity. The created positions shall take its effectivity upon the date of the final review of the Department of Budget and Management of its budgetary allocation.

Let this Ordinance be forwarded to the Provincial Governor, for his information and appropriate action and to the Department of Budget and Management , Cordillera Administrative Region, Baguio City for its information and appropriate action. Let copies hereof be furnished the Provincial Budget Officer, Provincial Treasurer , Provincial Accountant, Provincial Auditor, PGO-Personnel and other offices concerned, for their information and guidance.




