**AN ORDINANCE CREATING VARIOUS CAREER POSITIONS AND CREATING
VARIOUS CAREER POSITIONS IN LIEU OF THE ABOLITION/CONVERSION OF
VARIOUS VACANT POSITIONS IN THE LOCAL GOVERNMENT OF THE
PROVINCE OF BENGUET**

WHEREAS, proposed under the Executive Budget for CY 2014 are various positions for the different offices of the provincial government including positions which were created in lieu of some vacant positions under the Sangguniang Panlalawigan Office(SPO) and the Provincial Veterinary Office(PVET);
