WHEREAS, forwarded to this Sanggunian is the 1st Indorsement dated April 12, 2014 of Hon. Nestor B. Fongwan, Provincial Governor requesting for the abolition of one (1) Administrative Aide I and for the creation of the position Administrative Aide III (Driver I) in the Dennis Molintas Municipal Hospital;

WHEREAS, the services of the position of a driver is needed more than the services provided by an Administrative Aide I;

WHEREAS, the creation of the said position will not entail additional appropriation for Personal Services since the difference shall be charged from Personal Savings accumulated from the vacated position in the office;
