**CREATING VARIOUS CAREER POSITIONS IN THE LOCAL GOVERNMENT OF THE  
PROVINCE OF BENGUET.**

**WHEREAS**, due to exigency of public service, new positions were funded in the Appropriation Ordinance No. 14 – 02 (Supplemental Budget No. 2 CY 2014) for the offices of Provincial legal Office, Provincial General Services Office, Tourism Office of the Provincial Governor's Office, and the Sangguniang Panlalawigan Office;

**WHEREAS**, the appropriate ordinance for the creation of those positions is not yet passed however. Hence, this ordinance;


