PROVINCIAL ORDINANCE NO. 15 - 175

AMENDING SECTION ONE (1) OF PROVINCIAL ORDINANCE NO. 12-153 DATED FEBRUARY 20, 2012, ENTITLED: "AMENDING CHAPTER IV, SECTION 92 OF THE 2005 BENGUET REVENUE CODE, PARTICULARLY ON THE IMPOSITION OF HOSPITAL CHARGES AND FEES OF THE BENGUET GENERAL HOSPITAL".

EXPLANATORY NOTE

WHEREAS, the existing rates of fees and charges at the Benguet General Hospital are insufficient to cover its incurred expenses for services rendered to its clientele;

WHEREAS, the increase is reasonable to cover additional costs for services, acquisition of supplies, equipment and other necessary items;

NOW THEREFORE, on motion duly seconded,

BE IT ORDAINED BY THE SANGGUNIANG PANLALAWIGAN IN SESSION ASSEMBLED THAT:

Section 1. Section 1, Subsections 1.2 (Room Rates), 5 (Use of Equipment), & 14 (Use of Other Hospital Facilities) of Provincial Ordinance No. 12-153 are hereby amended to finally read as follows:
