**PROVINCIAL ORDINANCE NO. 2015-179**

**AN ORDINANCE CREATING VARIOUS CAREER POSITIONS IN THE LOCAL GOVERNMENT OF BENGUET**

**WHEREAS**, there were several career positions which were proposed and funded for the different offices of the provincial government under Appropriation Ordinance Nos. 15-05, 2015-06, 2015-07 and 2015-08 dated August 3, 2015, September 14, 2015 and October 26, 2015, respectively, that includes positions that were created in lieu of the abolition of some vacant positions under the PHO, KMCH, DMMH, PVet, SPO and AEH;

**WHEREAS**, the Sanggunian approved the creation and abolition of various career positions due to exigency of public service;

**NOW THEREFORE**, on motion duly seconded, be it

**BE IT ORDAINED BY THE SANGGUNIANG PANLALAWIGAN IN SESSION ASSEMBLED THAT:**
