AN ORDINANCE ABOLISHING VACANT POSITIONS UNDER THE LEGISLATIVE SERVICES AND UNDER THE HEALTH SECTOR SERVICES AND IN ITS STEAD CREATE VARIOUS POSITIONS IN THE PROVINCIAL GOVERNMENT OF BENGUET

“WHEREAS, proposed under supplemental budget no. 1 are various positions to be created in lieu of the abolition of vacant positions under the office of the Sangguniang Panlalawigan Office, Atok District Hospital and the Benguet General Hospital Economic Enterprise due to exigency of service;

NOW THEREFORE, on motion duly seconded,

BE IT ORDAINED BY THE SANGGUNIANG PANLALAWIGAN IN SESSION ASSEMBLED THAT:

SECTION 1. Abolition and creation of positions. Several positions that are recommended for creation in lieu of the abolition of vacant positions are presented below to cater to the increasing demand of public service.
