PROVINCIAL ORDINANCE NO. 16-193

AN ORDINANCE GRANTING AUTHORITY TO THE PROVINCIAL GOVERNOR TO AUGMENT FUNDS OF VARIOUS OFFICES UNDER THE EXECUTIVE DEPARTMENT, INCLUDING THE ECONOMIC ENTERPRISES, AND THE PROVINCIAL VICE GOVERNOR TO AUGMENT FUNDS UNDER THE OFFICES OF THE VICE GOVERNOR AND THE SANGGUNIANG PANLALAWIGAN OF THE PROVINCE OF BENGUET

WHEREAS, Chapter 4, Sec. 336 of the Local Government Code of 1991 provides: "Use of Appropriated Funds and Savings – Funds shall be available exclusively for the specific purpose for which they have been appropriated. No ordinance shall be passed authorizing any transfer of appropriations from one item to another. However, the local chief executive or the presiding officer of the sanggunian concerned may, by ordinance, be authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations."

WHEREAS, numerous requests for realignment of funds from the different offices of the Provincial Government of Benguet are being forwarded to the Governor and the Vice Governor to augment deficiencies in allotment in their respective budgets.

WHEREAS, to expedite the implementation of the programs of the requesting offices, realignment of funds is necessary.

NOW THEREFORE, on motion duly seconded,

BE IT ORDAINED BY THE SANGGUNIANG PANLALAWIGAN OF BENGUET IN SESSION, THAT:

Section 1. Title. This Ordinance shall be entitled: "Granting Authority to the Provincial Governor to Augment funds of Various Offices Under the Executive Department, Including the Economic Enterprises, and the Provincial Vice Governor to Augment Funds Under the Offices of the Vice Governor and the Sangguniang Panlalawigan of the Province of Benguet";

Section 2. Requests for Realignment. The respective offices who want to augment deficiencies in allotment in their respective budgets shall forward their request/s to the governor or vice governor, as the case may be, before the latter could act accordingly;

Section 3. Scope of Realignment. The funds to be realigned shall be from savings in other items within the same expense class;

Section 4. Checks and Balances. Lists of any and all realigned funds shall be furnished to the sangguniang panlalawigan for its information.


Section 5. Separability Clause. If, for any reason, any section or provision of this Ordinance is declared invalid or unconstitutional, other sections or provisions thereof which are not affected thereby shall continue to be in full force and effect.


Section 6. Effectivity. This Ordinance shall take effect upon its approval in accordance with the provisions of the Local Government Code of 1991, as amended, and until December 31, 2016.


Let this ordinance be forwarded to the Provincial Governor for his information and appropriate action.


