**PROVINCIAL ORDINANCE NO. 18 - 230**

**AMENDING SECTION 6 OF PROVINCIAL ORDINANCE NO. 15-172 ENTITLED: "INSTITUTIONALIZING THE GRANTING OF INCENTIVES AUGMENTATION TO QUALIFIED BARANGAY HEALTH WORKERS (BHWs), FINANCIAL ASSISTANCE TO CHILD DEVELOPMENT WORKERS (DAY-CARE WORKERS), AND TO GOVERNMENT BARANGAY NUTRITION SCHOLARS (BNSs) IN THE PROVINCE OF BENGUET, PROVIDING THE GUIDELINES AND APPROPRIATING FUNDS THEREFOR".**

**WHEREAS**, on June 29, 2015, the Sangguniang Panlalawigan of this Province approved Provincial Ordinance No. 15-172 providing incentives or financial assistance to Barangay Health Workers (BHWs), Child Development Workers (Day-Care Workers), and Barangay Nutrition Scholars (BNSs) as recognition of their efforts in community building;

**WHEREAS**, there is an imperative need for additional fund to augment the budget appropriated under Provincial Ordinance No. 15-172, so as to encourage them to continue their voluntary services for the general welfare of the People of Benguet, which are worthy of recognition;

**NOW THEREFORE**, on motion of Hon. Jim G. Botiwey duly seconded, be it

**BE IT ORDAINED BY THE SANGGUNIANG PANLALAWIGAN OF BENGUET IN SESSION THAT:**


**SECTION 1.** Statement of Policy. Section 6 of Provincial Ordinance No. 15-172 shall now be finally read as follows:

**"SECTION 6. APPROPRIATION.** An annual amount shall be appropriated under the General Fund for this purpose as follows:

- A) Not Less Than Two Million Pesos (PhP2,000,000.00) for Incentive Augmentation for Barangay Health Workers (BHWs);
- B) Not Less Than Seven Hundred Fifty Thousand Pesos (PhP750,000.00) for financial assistance to Barangay Nutrition Scholars (BNSs); and
- C) Not Less Than One Million Pesos (PhP1,000,000.00) for financial assistance to Child Development Workers (Day-Care Workers)."

**SECTION 2. EFFECTIVITY.** This Ordinance shall take effect in accordance with the provisions of the Local Government Code of 1991, as amended.
